## Environmental Requirements

To safely install your XTM 1500 Series device, we recommend that you:

- Install it in a network rack
- Put it in a secure area, such as a locked room, to keep the device from people who do not have permission to use it
- Connect it to a conditioned power supply to prevent damage from sudden power changes

# Hardware Description

## Front View

The front of the device.



A close-up of the front left side of the device.



### LCD indicator panel

Device status information appears on the LCD screen. Press the buttons below the screen to change the information that appears on the screen.

### LCD console buttons

Press the LCD console buttons to see status information and start recovery procedures. To boot the device in safe mode, press and hold the down arrow button when you power on the device.

For detailed information about the LCD indicator panel and the LCD console buttons, see "Sicherheitshinweise" on page 11.

### Power (⏻)

When the device is powered on, the power indicator is green.

### Arm/Disarm

When the device is armed, this indicator is green. When the device is disarmed, this indicator is red.

### Storage (💾)

When there is activity on the hard drive or the compact flash, this indicator is yellow.

### Serial port

An RJ45 connector for the serial interface. is located to the right of the LCD screen. You can connect to this serial interface to log in to the Fireware XTM command line interface.

For more information about the command line interface, see the current *Fireware XTM Command Line Interface Reference*.

### Dual USB interfaces

Connect a USB storage device to use for USB backup and restore, or to store a support snapshot.

For more information about USB functions, see the current *WatchGuard System Manager Help* or *Fireware XTM Web UI Help*.

All network interfaces are located on the front of the device.



From the left, the indicators and connectors are:

#### Network interfaces — XTM 1520, 1520-RP

XTM 1520 has a total of 14 network interfaces. All network interfaces have standard RJ45 connectors and are labeled 0, 1, 2, 3... 13.

#### Network interfaces — XTM 1525, 1525-RP

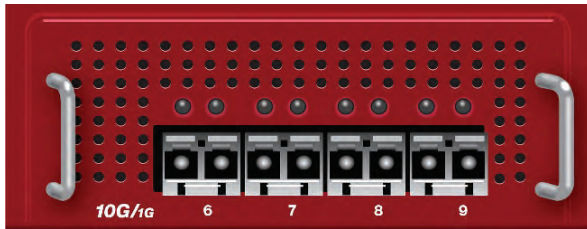
The XTM 1525 has a total of 10 network interfaces. The six interfaces on the left have standard RJ45 connectors and are labeled 1, 2, 3, 4, 5, 6. The four network interfaces on the right have fiber connectors and are labeled 6, 7, 8, 9.

**10G/1G fiber interfaces**

The XTM 1525 has four 10G/1G fiber interfaces located on the right.

**Rear View - XTM 1520, 1525**

The AC receptacle, power switch, and fans are located on the rear of the device.



**Fans**

The fans decrease the internal temperature of the device. The fans start at maximum RPM when the device is powered on. The device continually adjusts the fan speed based on the external temperature and device CPU load.

**AC receptacle**

Accepts a detachable AC power cord supplied with the device. The power supply for the device is a WatchGuard standard auto-sensing AC power supply.

**Power switch**

Controls the power supplied to the device.



**Caution**

You must always disconnect the power supply before you remove the cover of the XTM 1500 Series device.



## Rear View - XTM 1520-RP, 1525-RP

The fans, replaceable and redundant power supplies, AC receptacles, power switch, and alarm override switch are located on the rear of the device..



### Fans

The fans decrease the internal temperature of the device. The fans start at maximum RPM when the device is powered on. The device continually adjusts the fan speed based on the external temperature and device CPU load.

### AC receptacles on each power supply

Each AC receptacle accepts a detachable AC power cord supplied with the XTM device. Each power supply for the device is a WatchGuard standard auto-sensing AC power supply.

### Replaceable power supplies and power switch

There are two power supplies on the XTM 1520-RP and 1525-RP devices, each with a power indicator light at the top. The power switch activates both power supplies.

It is not necessary to turn off the XTM device to replace a failed power supply.

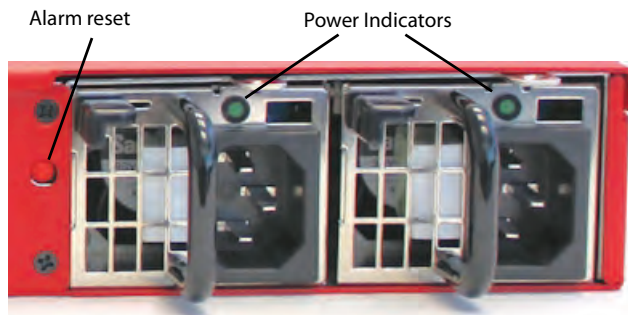
If one of the power supplies fails, the green power indicator light for that power supply goes out and an audible alarm sounds.

### Caution

You must disconnect power the AC power cord from both power supplies before you remove the cover of the XTM 1520-RP or 1525-RP device for any reason.

### Alarm reset button

If either of the two power supplies fails for any reason, an audible alarm sounds. To silence the audible alarm, press the reset button located to the left of the power supplies.



## Power Supply Replacement Instructions

---

The XTM 1520-RP and 1525-RP have redundant hot-swappable power supplies. You can replace a power supply while the device is powered on, with the power connected to the other power supply.



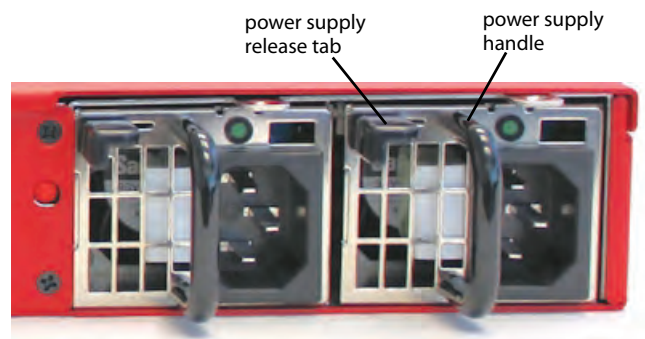
### Caution

The power supply can be extremely hot when first removed. Avoid any contact until the metal has cooled. Do not put the power supply directly on a heat sensitive surface.

---

To replace a power supply:

1. Disconnect the power cable from the power supply you want to replace.
2. Slide the power supply release tab to the right, and then use the power supply handle to pull the power supply out.
3. Slide the replacement power supply into the open slot.
4. Press firmly on the face of the power supply until the release tab locks it in place.
5. Connect the power cable to the new power supply. If the replacement is successful, the power indicator light for the new power supply is green.



## Rack Mount Instructions

---

Each WatchGuard XTM 1500 Series device is shipped with a rack mount kit. When you install the device in a rack, make sure you consider:

**Elevated Operating Ambient Temperature**

If you install the device in a closed or multi-unit rack assembly, the operating ambient temperature of the rack environment may be greater than room ambient. Make sure the ambient temperature of the rack environment is within the certified operating range specified in this Hardware Guide.

**Reduced Air Flow**

When you install the XTM 1500 Series device in a rack, make sure that the amount of air flow required for safe operation of the equipment is not compromised.

**Mechanical Loading**

When you mount the XTM 1500 Series device in the rack, avoid hazardous conditions caused by uneven mechanical loading.

**Circuit Overloading**

Make sure you connect the XTM 1500 Series device to the power supply circuit to make sure there is no overloading of the circuits, and no impact on overcurrent protection and supply wiring.

**Reliable Grounding**

Make sure all rack-mounted equipment is correctly grounded. For example, use power strips instead of direct connections to the branch circuit.

## Use the LCD Interface

---

You can use the LCD interface and buttons for different operations.

The XTM 1500 Series device can operate in three modes:

### **Normal Mode**

This is the normal operating mode for the device. The XTM 1500 Series device boots from the Fireware XTM OS and operates with the rules set in the configuration file you have saved to the device.

### **Safe Mode**

You can use safe mode to get access to an XTM 1500 Series device when you cannot connect to the device in normal mode. You can also use safe mode to reset device passphrases when you do not know or have forgotten them. To recover the device when you start it in safe mode, you must use the WSM Quick Setup Wizard or the Web Setup Wizard.

You must start the XTM 1500 Series device in safe mode to use the Quick Setup Wizards. In safe mode, the device runs Fireware XTM and is configured with factory-default IP addresses. When you put the device in safe mode, the license files and certificates are saved. You can then use the saved files if you reconfigure a device with one of the setup wizards.

To start an XTM 1500 Series device in safe mode, press and hold the down arrow button on the device front panel when you power on the device. Hold down the button until "Safe Mode Starting" appears on the LCD screen. When the device is in safe mode, the model number followed by the word "Safe" appears on the LCD screen and the factory default IP address for Eth1 is 10.0.1.1/24.

### **Recovery Mode**

You can start your WatchGuard XTM device in recovery mode if you want the WSM Quick Setup Wizard to force a Fireware XTM v11.x OS installation regardless of the version that is currently installed. When you start the device in recovery mode, the Quick Setup Wizard installs a new OS image and removes all existing configuration settings and feature keys.

To start an XTM 1500 Series device in recovery mode, press and hold the up arrow button on the device front panel when you power on the device. Hold down the button until "Recovery Mode starting" appears on the LCD screen. In recovery mode, the Eth1 interface uses the factory default IP address 10.0.1.1/24, and the device is ready to be discovered by the WSM Quick Setup Wizard.

For more information about how to use safe mode and recovery mode, see the *WatchGuard System Manager Help* or *User Guide*.

## LCD Keypad Button Control

Below the LCD screen, there are four arrow buttons.



### Up Arrow

Press this button to increase the value of a selected item, or move up in a group menu.

### Down Arrow

Press this button to decrease the value of a selected item, or move down in a group menu.

### Left Arrow

This is the "selection" or "Enter" button. Press it to confirm your menu selections and select different options.

### Right Arrow

Press this button to move between fields in the LCD display. You can use it like the "TAB" key in a Windows dialog box.

## Use the LCD Interface in Normal Mode

The XTM 1500 Series device automatically boots in normal mode, unless you specifically put it in safe mode. To operate, the device uses the installed Fireware XTM OS and the rules in the configuration file you have saved to the device.

You can use the four arrow buttons to see information about the device on the LCD screen. In normal mode, you use the buttons to navigate the hierarchical LCD interface menu.

In normal mode, the LCD interface menu includes these items:

### **Hardware Monitor**

**XTM device model number**

**XTM device serial number**

**CPU temperature**

CPU temperature and system temperature

**CPU fan status**

Case cooling fan speeds for the four device fans

**Voltage**

CPU core voltage, the battery voltage, and the 3.3V power supply voltage

### **Configuration Information**

IP addresses and subnet masks assigned to each interface on the device

Default gateway

### **Appliance Software Information**

OS type

Fireware XTM build number

### **Uptime**

Time interval since the device was last restarted

Time interval since a configuration was saved to the device

### **Load**

Load average, shows the average system load for the past 1, 5, and 15 minutes

### **Memory usage**

Current memory use on the XTM 1500 Series device

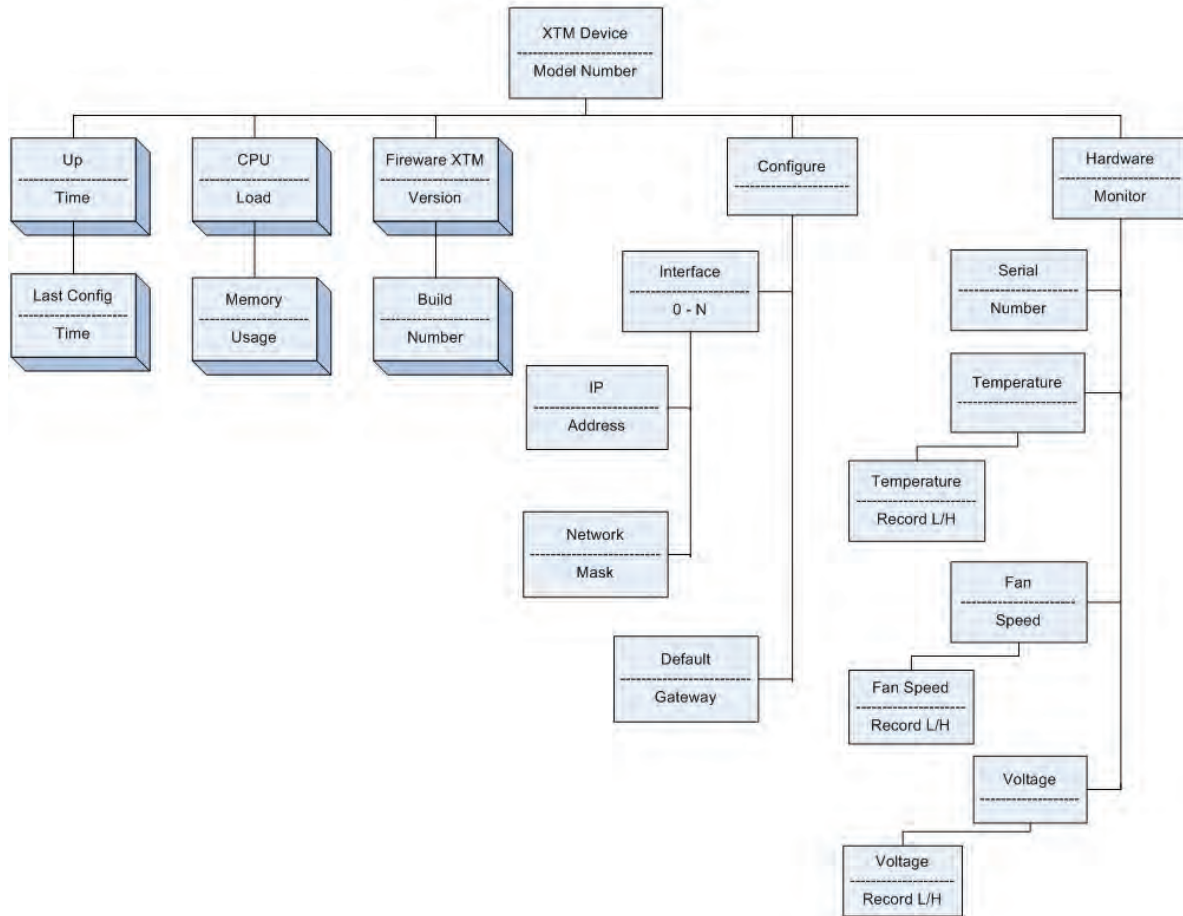
To navigate the LCD interface menu:

- To move forward through the list of categories, press the **Right Arrow** button.
- To move up and down in the menu and see information in a category, press the **Up Arrow** and **Down Arrow** buttons.

To stop the auto-cycle of the LCD screen, press any button.

To see the CPU temperature of the XTM 1500 Series device on your LCD screen:

1. Press the **Right Arrow** button to scroll through options until **Hardware Monitor** appears.
2. Press the **Down Arrow** button to see the options below that menu item.
3. Press the **Right Arrow** button to scroll through the items in the **Hardware Monitor** menu until **CPU temperature** appears.
4. Press the **Up Arrow** button to return to the main category level.




